4. APPLICATION / LIMITATION:

4.1- The UNIFIRE FORCE monitor is approved for installation on ships built with the additional class notation "Fire fighting ship E" in water system.

4.2- The monitor is capable of remote and local control.

4.3- The control system is to comply with the relevant provisions of BV Rules Part C Chapter 3 Section 1 and Section 2.

4.4- The monitor supports onboard are to be of robust construction and capable of withstanding the reaction forces of the water jet.

4.5- Monitors shall be tested when fitted and characteristics found in compliance with BV Rules Chapter 16.

5. PRODUCTION SURVEY REQUIREMENTS:

5.1 - The "UNIFIRE FORCE 50" and "UNIFIRE FORCE 80" are to be supplied by "UNIFIRE AB" in compliance with the type and the requirements described in this certificate.
